# FRONT LINE WORKERS ARE UNSUNG HEROES - WORLD DAY AGAINST TRAFFICKING IN PERSONS

Commemorating, 'World Day Against Trafficking in Persons', Mahita - Plan India under the aegis of Girls Advocacy Alliance to honor the front line workers including law enforcement officers, Police, health personnel, psychologists, government officials and several others who directly and indirectly invest efforts in saving women and children from being trafficked either for bonded labour or sexual exploitation, series of webinars with various stakeholders were organised on July 30.

The program was attended by 200 participants from six districts of Telangana and three districts of Andhra Pradesh including DCPOs, CDPUs, Sakhi representatives, Bal Raksha Bhavan Coordinators, JJB Board members, CSOs, Child line coordinators, Religious leaders, Caste leaders, Community leaders, DCPU and Mahita staff.



The Sakhi centers in Mehbubnagar responded well to the Gender Based Violence issues and were involved in reporting and rehabilitation. The way they functioned was very professional in Covid situation. The mobile safety teams were available for the assistance and have Smt Rema Rajeshwari, IPS done commendable work. Dealing with secondary victimization **Superindent of Police** has to be institutionalised at all levels. Together, all our small Mehbubnagar efforts will lead to a big change.



While we think child trafficking is a physical phenomena, Cyber space is a another challenge/threat. The open zoom forums, chat rooms are serious matters of concerns and we need to develop our capacities to

address them. The only way is engaging with vulnerabilities. People say that they will wait for the lockdown to be over, but we cannot wait for the victim to give complaint of crime. We need to find new ways to reach victim and do justice.

government statutory bodies should use voluntary system to spread awareness.



Every one in five are prone to violence and risk, say studies. Telangana state stands among top 5 in the country with respect to trafficking. All the government Ms Shalini Prabhata, Manager

departments are working; however Covid 19 has increased the vulnerability of getting trafficked. Since children are at home, the rate of child marriages and child labour is rising, which are also various forms of trafficking. So we need to intensify efforts during Covid especially in prevention and protection.



AHTU (Anti Human Trafficking Unit) is one of the important stakeholders after government had passed new laws with Nirbhiya incident to ensure each

district to have a budget of 100 crore being separately allocated for its functioning. It is important that it should have a victim-centric approach and create awareness about human trafficking.

#### WHAT DOES STATS SAY?

- People are trafficked for sexual exploitation, forced labour, forced begging, forced marriage, for selling children and as child soldiers as well for removal of organs.
- Women make up 49% and girls 23% of all victims of trafficking
- Sexual Exploitation is the most common form of exploitation (59% share) followed by forced labour (34% share)
- Most victims are trafficked within their countries' borders - those trafficked abroad are moved to the richest countries
- INDIA stands 5TH among various countries across the world in terms of trafficking especially trafficking for sexual exploitation and we need to work on this.
- **TELANGANA** state stands among top 5 in the country with respect to trafficking

Advance planning is required to address the issues, especially during emergency situations, and as first respondents we have a lot of responsibility.





# **INCREASING LEGAL AGE OF MARRIAGE FOR WOMEN FROM 18 TO 21 YEARS**

Finance Minister, Nirmala Sitharaman during her Budget Speech 2020-21, announced to revise the legal age of marriage for women from 18 years to 21 years. In February 2020, it was announced to constitute a task force that will present its recommendations over this in 6 months' time period. The high-level committee constituted by the Central Government will submit its recommendations into the matter by July 31, 2020. The task force will look into matters related to motherhood and marriage at an early age.

With an aim of understanding perspectives of different stakeholders at district level on increasing the marriage age, Girls Advocacy Alliance has organized a series of meetings with Religious leaders, Child Welfare Officers, Caste leaders and government officials.





Mr J Srinivas Rao – Chairman, Telangana State Commission for Protection of Child Rights (TSCPCR) said as per World Health Organisation (WHO), 18 years is still a formative phase and not the right age for a woman to bear a child. Once a girl gets married, practically it is very difficult to continue education except in situations where there is a understanding Mother in Law at home, he added.

#### Views of Youth advocates:

- At the age of 21 girls are capable to take their own decisions.
- At the age of 18, they are not mentally matured and are not completely educated.
- Some youth advocates ask to increase boys' age from 21 to 24.
- · If govt increase age from 18 to 21, then they should provide education and skill development centres in nearby places.
- They have expressed their willingness to counsel parents and school dropouts.

# STRATEGIES TO ARREST DROPOUTS AMONG GIRLS

A district level meeting with community leaders on addressing the issues of girls dropping out of school and plans to mitigate the situation was held in Vishakapatnam, Andhra Pradesh. The zoom meeting was attended by 14 members.

Community Leaders have agreed to put their efforts to minimize the dropouts especially girl child. Covid-19, Migration from work place to Home village, children education problems (Like Transfer certificates, study and conduct certificates, Aadhar Links etc.), status of Govt .implementation schemes in the schools. (Ammavodi, Vidya devena, Vasati devena, Nadu Nedu etc.), problems faced by rural children due to online education, forced Child marriages and child labor were some of the issues discussed.

# **BUILDING CHILD MARRIAGE FREE GRAM PANCHAYATS IN THE STATE**

District level zoom meetings with PRI members, AWTs, Supervisors, CDPOs and representatives on making Child Marriage Free Gram Panchayats were held in Andhra Pradesh and Telangana.

"Child Marriages are the first barrier for the development of young girls", said Ms Vijaya Laxmi, Child District Protection Officer (CDPO), Bela during the zoom meetings. She further shared that the Anganwadi teachers are meeting all the households and explaining about Covid 19, health, hygiene, nutrition and the effects of child marriage.

The AWTs and supervisors responded very positively and ensured that there are no child marriages taking place in their villages. Community leaders opined that parents are taking steps to get their child get married early due to Covid situation as there is low monitoring by government in rural areas. The non-functioning of schools in villages and lack of access to Digital Learning applications by poor families are forcing children to turn victims of child marriage and child labour, they shared.

## **TEACHERS UNION MEETINGS ON 'NEW EDUCATION POLICY'**

With an aim of orienting Civil Society Organisations (CSOs) on the proposal of New Education Policy of India, district level zoom meetings were held in Andhra Pradesh and Telangana.

Teacher representatives shared that the new education policy was good, but it is not discussed widely in the parliament. They opined that it concentrates on students skills development. It also changes curriculum and 3+3+5+4 system, research courses are deleted and teacher education is now extended to 4 years.

Mr Kiran Kola, Teacher from Adilabad said that it is imperative to create attractive environments in schools by including toys, games which inspires children to come schools. He opined that Teacher education should be a professional course and training exams held in Bit type exam format is not scientific. "We understand the Teacher's caliber by demonstration method only hence it has to be made compulsory while recruitments", he said. Incorporating Vocational Training in education system is a welcome step by the government, he further added.
